The grievance of the petitioner is he has given a complaint under Section 156(3) Cr.P.C., in CrI.M.P.No.737 of 2023 before the learned Judicial Magistrate, Srirangam and the same was ordered and the complaint was referred to the first respondent for enquiry and further action.
