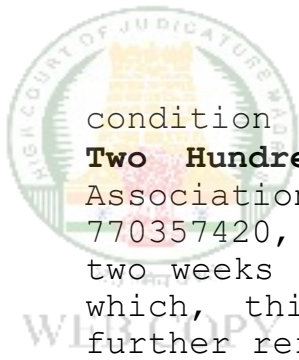
PRAYER IN CRL RC(MD)SR.No. 23561 of 2023:
