2.The case of the prosecution is that on 09.07.2022 at about 08.30 a.m., by following secret information given by the police informant, the respondent police came to Karur Vanjiamman Kovil near Amaravath River bed and arrested the petitioner and A2 and seized the narcotic substances from them. 5.It is seen that this is the fourth application for bail and the petitioner's earlier applications were dismissed by this Court and there is no change in circumstances of the case to consider the present bail petition even after dismissal of the earlier petitions, hence this court is not inclined to grant bail to the petitioner.

6.Hence the petition stands dismissed.
