2.It was submitted that repeatedly, the accused person has filed extension of time applications. Even though repeatedly, the time was granted, he did not comply the condition imposed upon him while granting anticipatory bail.

3.There is a clause in the order to the effect that if the condition is not complied within the time stipulated, then the anticipatory bail granted to the petitioner should stand dismissed automatically. Therefore, the anticipatory bail granted to the petitioner is hereby cancelled. Accordingly, the petition filed by the defacto complainant in CrI.M.P.(MD).No.9860 of 2023 is allowed and petition filed by the accused person in CrI.M.P.(MD).No.9863 of 2023 seeking extension of time is dismissed.
