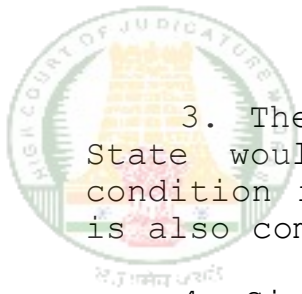
Prayer in Crl A(MD)No. 303 OF 2023:
