3. The learned counsel appearing for the petitioner represented that so far he has not received any communication either from the police or from the concerned jurisdictional Magistrate.

4. In view of the fact that already negative report was filed, the petitioner is at liberty to approach the concerned jurisdiction Magistrate and work out his remedy by filing appropriate application. The

respondent police is also directed to serve notice to the petitioner with regard to the closure report within a period of one week from the date of receipt of a copy of this order.
