5. Taking into consideration the facts and circumstances of the case, this Court is inclined to modify the condition imposed and there shall be a direction to the petitioner to report before the respondent Police on the first Monday of every month until further orders.

6. This Criminal Miscellaneous Petition is disposed off with the above terms.
