This criminal original petition has been filed seeking to quash the FIR in Crime No.94 of 2020 on the file of the first respondent Police.

2.The contention of the petitioner is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.94 of 2020 for the offences punishable under Sections 294(b), 324 and 506(2) of IPC.

3.When the matter is taken up for hearing, the learned Government Advocate (Crl. side) would submit that after completing the investigation final report has been filed before the learned Judicial Magistrate No.I, Tirunelveli, through e-filing and the same has not been taken cognizance so far. Hence, the prayer sought for in this petition has become infructuous.

4.Since the final report has been filed before the concerned Court, the petitioner can workout his remedy through appropriate proceedings, if so aggrieved by the contents of the final report. The learned Judicial
