ORDER

Heard the learned counsel on either side.

2. The writ petitioner's husband joined the respondent Corporation in the year 1982. He retired on 31.03.2020. He died on 01.06.2021. However, his terminal benefits were settled only on 02.06.2021. It is well settled that for such belated settlement, the employee is entitled to interest. I therefore direct the respondent Corporation to pay interest to the writ petitioner computed at the rate of 6% per annum on the belated disbursement from the date of immediately after the death of her husband till date of settlement. The interest amount shall be paid within a period of twelve weeks from the date of receipt of a copy of this order.
