This petition has been filed seeking to quash the impugned FIR in Crime No. 100 of 2019 on the file of the 1st respondent police.

2.The contention of the petitioners is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.100 of 2019 for the offences punishable under Sections 294(b), 323 and 506(i) of IPC, Sections 3(1)(r), 3(1)(s) and 3(2)(va) against the petitioners. Seeking quashment of the same on various grounds this petition has been filed.
