This criminal original petition has been filed seeking to quash the FIR in Crime No.109 of 2022 dated 21.06.2022 on the file of the first respondent Police.

2.The contention of the petitioners is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.109 of 2022 for the offences punishable under Sections 143, 341, 294(b), 353, 448 and 506(ii) of I.P.C., Section 4 of Prevention of Damage to Public Property Act, 1984 and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 2002.
