COMMON ORDER

The petitioners have filed these writ petitions apprehending that that an attempt is made to disqualify the elected members and to conduct a fresh election for the 5th respondent Co-operative Societies.

2. The learned Additional Advocate General appearing for the respondents submits that for the purpose of enumerating the voter list, a circular was issued by the first respondent/the Registrar of Co-operative Societies to enumerate the voter list after adding the names of new members and deleting the names of deceased members. Misconstruing the same, the petitioners have filed these writ petitions.

3. The learned Additional Advocate General further submits that neither the Government nor the Department is having any inclination to
