The petitioners are directed to submit all the relevant documents before the third respondent within a period of four (4) weeks from today.

In the light of the above, there shall be a direction to the third respondent to deal with the documents submitted by the petitioners and pay the compensation amount that was fixed under the award. This process shall be completed within a period of twelve (12) weeks from the date of receipt of the copy of this order.

6. This Writ Petition is disposed of with the above directions.
