ORDER

Therefore, the respondents are directed to survey the land, fix compensation as per the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act, 2013 and consider the petitioner's representation, dated 26.09.2020, within a period of Eight weeks, from the date of receipt of a copy of the order.

5. With these observations and directions, this Writ Petition is allowed. No Costs.
