This criminal original petition has been filed seeking to quash the FIR in Crime No.6 of 2022 on the file of the first respondent Police.

2.The contention of the petitioner is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.06 of 2022 for the offences punishable under Sections 7 and 8 of Protection of Child from Sexual Offences Act, 2012.

3.When the matter is taken up for hearing, the learned Government Advocate (Crl. side) would submit that after completing the investigation final report has been filed before the learned Sessions Judge, Special Court for POCSO Act Cases, Sivagangai and the same was taken cognizance in Spl.S.C.No.48 of 2023. Hence, the prayer sought for in this petition has become infructuous.
