2.According to the learned counsel for the petitioner, the petitioner has filed a complaint alleging that a person, by name Subash Chandrabose has committed rape on her.

3.The learned Government Advocate (Crl.side) submits that the petitioner herself has not cooperated with the enquiry and the police would complete the preliminary enquiry and close the matter within a period of four weeks.

4.During the course of arguments, Mr.T.Veerakumar learned counsel appeared on behalf of the wife of Subash Chandrabose/the proposed accused make certain allegations on the petitioner.
