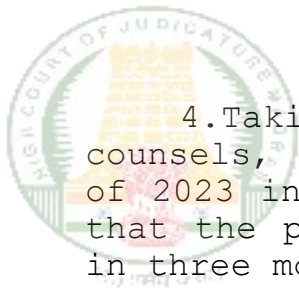

This petition has been filed to relax the condition imposed on the petitioner in Crl.MP(MD)No.1664 of 2023 in Crl.O.P.(MD)No.19605 of 2022 on 01.02.2023.

2.The learned counsel for the petitioner submitted that the petitioner has been complying the conditions regularly and he prayed for relaxation of the said condition.

3.The learned Government Advocate (Crl. Side) submitted that the petitioner has been complying the conditions regularly and investigation is still pending and also the petitioner is having five previous cases.
