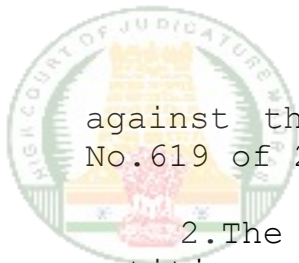
Prayer in CRL A(MD). 619/ 2022 :
