Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents to forthwith provide suitable alternative employment as envisaged under Section 20(4) the Rights of the Persons with Disabilities Act 2016 with continuity of Service , pay protection, backwages for the disengagement period and continue to pay the petitioner wages to him till the date on which the respondents provide him alternative light duty.
