ORDER

This Writ Petition is filed seeking a direction to the respondent No. 1 to give necessary communication to the 2nd and 3rd respondents so as to cause the Look Out Circulars opened as against 4th and 5th respondents in view of their involvement in the criminal case registered vide Crime No. 24 of 2021 pending on the file of the 4th respondent and on the strength of the petitioner's representation dated 03.09.2021 forthwith.

2. The learned counsel for the petitioner submitted that on the basis of the complaint given by the petitioner, a case in Crime No.24 of 2021 on the file of the 4th respondent was filed.

3. The learned Additional Public Prosecutor submitted that after completion of investigation, final report has been filed before the

concerned court and thereafter, the names of the respondents 4 and 5 are deleted from the final report.

4. Now the grievance of the petitioner is that he has not received any notice from the concerned court or the officials before deleting their names from the final report.

5. In view of the above submission, the first respondent is directed to issue notice regarding deletion of the names of the respondents 4 and 5. After receiving notice, the petitioner may workout his remedy before the concerned court.

6. Accordingly, this Writ Petition is dismissed as infructuous. Consequently, connected miscellaneous petition is closed.
