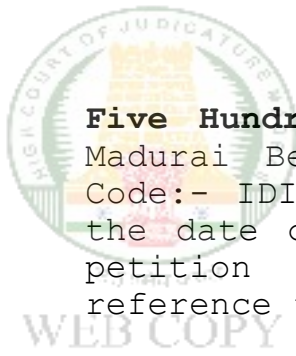
PRAYER IN CRL.RC(MD)SR.No.25012/2023:
