2.Learned Standing Counsel appearing for the respondents 2 & 3, on instructions, submitted that the petitioner was adequately compensated and if he is not satisfied with the compensation amount, he can work out his remedy before the appropriate civil forum u/s.16(3) of the Indian

Telegraph Act. Holding so, the representation of the petitioner dated

17.06.2022 has already been rejected.

3.Learned Standing Counsel is directed to furnish a copy of the order passed by the respondents in consideration of the petitioner's representation dated 17.06.2022 to the petitioner within a period of two weeks. Liberty is granted to the petitioner to work out his remedy in the manner known to law.
