Now, both the parties appeared and the claimants agreed to receive the award amount in the following terms:-

The claimants agreed to receive a sum of Rs.17,00,000/- (Rupees Seventeen Lakhs only) with interest at the rate of 7.5% from the date of petition till the date of deposit.

The appellant/ Insurance company agreed for the said terms. The Insurance Company is directed to deposit the entire award amount after deducting the amount already deposited, if any, within a period of six (6) weeks from the date of receipt of a copy of this order.

The respondents 1 and 2 / claimants are entitled to withdraw the award amount as per the apportionment awarded by the tribunal with accrued interest, on filing necessary application before the Tribunal.
