3.I find no reason to modify the condition imposed by this Court. Let the petitioners shall comply the condition. However, time is extended for a period of 15 days, from the date of receipt of copy of this order.

4.Accordingly, the petition seeking modification is dismissed and petition seeking extension of time is allowed.
