ORDER

This Writ Petition is filed seeking for a direction to the respondents 1 to 3 not to interfere with the civil dispute existing between the petitioner and one Jothi.

2.It is submitted by the learned counsel for the petitioner that one Jothi stated to be the first wife of elder brother of the petitioner has filed O.S.No.10 of 2016 on the file of the I Additional District Judge, Tiruchirappalli, seeking partition of the schedule of properties and the said suit came to be dismissed on 2nd March 2020. Aggrieved by the same, the said Jothi and others have preferred an appeal suit in A.S.(MD).No.311 of 2021 and the same is still pending before this Court. However, the said Jothi stated to have filed a petition before the third respondent Police, who has gone to the extent of issuing a notice and summoning the petitioner and gave a direction to part with some property in favour of the said Jothi. The said third respondent stated to have drafted a copy of the proceedings in his own writing and got the
