ORDER

This Writ Petition is filed in the nature of Writ of Mandamus, directing the Respondents No. 1 to 5 to take necessary action against the Respondents No. 6 and 7 by conducting an enquiry based on the petitioner's representation dated 26.07.2022, within a stipulated time as fixed by this Court.

2. Learned Government Advocate (Crl.side) submitted that on the basis of the complaint given by this petitioner, enquiry was undertaken in C.No.A4/5119/2022. Similarly, the counter party has given a complaint that was also enquired along with the present complaint. During the course of the investigation, it is found that it is an issue between the

parties over a land. Therefore, by advising the parties to resolve the issue through appropriate civil proceedings, the complaints were closed.
