ORDER : The Court made the following order :-

The petitioner/Sole Accused, has been arrested on 06.03.2022 by the respondent Police for the alleged offence punishable under Sections 5(l), 5(n), 5(j)(ii) r/w.6(1) of POCSO Amendment Act, 2019, in Crime No.4 of 2022 on the file of the

2. The case of the prosecution is that the petitioner herein, who is the father of the minor victim had committed penetrative sexual assault on the minor victim, due to which she got pregnant and later it was aborted. Hence, the complaint.

3. The learned Additional Public Prosecutor would submit that the victim is the daughter of this petitioner and Act 14 has been invoked as against this petitioner.

4. Since Act 14 has been invoked against the petitioner, he is not entitled for bail at this stage. The petitioner is directed to workout his remedy only after the above said disposal of H.C.P(MD) No.469 of 2023, which is pending before the Division Bench of this Court. Without going into merits of this case, this Criminal Original Petition stands dismissed.
