Registry is directed to restore the appeals on file and list the same for final hearing on 14.03.2023

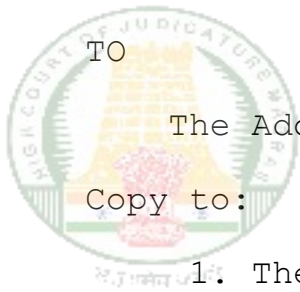
