ORDER

This criminal original petition has been filed seeking to quash the FIR in Crime No.321 of 2018 on the file of the first respondent Police.

2.The contention of the petitioners is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.321 of 2018 for the offences punishable under Sections 147, 148, 294(b), 323, 324, 506(2) and 448 of I.P.C.

3.When the matter is taken up for hearing, the learned Government Advocate (Crl. side) would submit that after completing the investigation final report has been filed before the learned Judicial Magistrate, Uthaqmapalayam, and the same was taken cognizance in C.C.No.349 of 2023. Hence, the prayer sought for in this petition has become infructuous.

4.Since the final report has been filed before the concerned Court, the petitioner can workout his remedy through appropriate proceedings, if so aggrieved by the contents of the final report.
