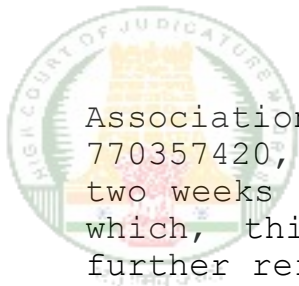
PRAYER IN CRL RC(MD) SR.No.26027 of 2023:
