2. The case of the prosecution is that the accused persons had illegally transported $\frac{1}{2}$ unit of river sand without any valid permit in the vehicle. Hence, the complaint.

3. The learned counsel for the petitioner would submit that the petitioner is an innocent and is no way connected in this case. The petitioner is the owner of the vehicle, which is used for committing the above said offences. Only on that ground, this petitioner has been implicated in this case.

4. The learned Government Advocate (Crl. Side) would submit that the petitioner is involved in previous cases in similar nature.

5. Considering the facts and circumstance of this case and considering the bad antecedent of this petitioner, this Court is not inclined to grant anticipatory bail to the petitioner. Hence, this criminal original petition is dismissed.
