Though this Court granted an interim suspension of sentence on 18.08.2023, which was subsequently extended on 20.09.2023 till 27.09.2023, enabling the petitioner to settle the matter amicably, it is seen that till date, the petitioner has not taken any steps to settle the matter. Hence, this Court is not inclined to extend the interim suspension of sentence granted earlier.

2. Accordingly, this Criminal Miscellaneous Petition stands dismissed.
