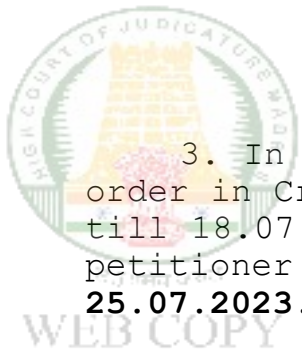
PRAYER IN CRL.MP(MD) .8956/2023:
