ORDER

This petition is filed seeking for a direction to the learned Judicial Magistrate, Thirumangalam to dispose of C.C.No.447 of 2023 within the time frame to be fixed by this Court.

2.It is submitted by the learned counsel for the petitioner that on a complaint given by the petitioner/defacto complainant, a case in Crime No.62 of 2023 was registered against the accused and after completion of the investigation, charge sheet is filed and the same was taken on file in C.C.No.447 of 2023 by the learned Judicial Magistrate, Thirumangalam and it is also submitted by the learned counsel for the petitioner that since the accused is intending to go abroad, on account of the pendency of this case, he is unable to take steps to leave this country.

4.Charge sheet is filed against the accused very recently and there are number of old cases pending consideration by the trial Court. In the normal
