5.Taking into consideration the submissions made by both the counsels, this petition is dismissed as not pressed, in so far as the first petitioner is concerned and this petition is ordered in so far as the second petitioner and the condition imposed by this court in Crl.O.P.(MD)No.8013 of 2023 is modified to the effect that the second petitioner shall report before the concerned Court once in month, ie., on every first working day, at 10.30 a.m., until further orders.
