On receipt of the same, the fourth respondent shall call all the interested parties for enquiry and after hearing them, a final decision shall be taken on its own merits and in accordance with law and appropriate orders shall be passed. This process shall be completed within a period of eight (8) weeks from the date of receipt of the representation from the petitioner.
