2. The case of the prosecution is that on 30.06.2023, the petitioner is a non-teaching staff and the defacto complainant's daughter is a teaching staff and due to the quarrel between them, the petitioner behaved indecently with her. Hence, the complaint.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent and he has not indulged in such sort of activities. Due to previous enmity, the defacto complainant has given a false complaint against the petitioner.

4. The learned Government Advocate (Crl. Side) would submit that there was motive between the parties and both are working as Teacher in the same school.

5. Reading of the First Information Report shows the indecent behaviour of the petitioner to the defacto complainant.

6. Considering the seriousness of the above said occurrence, this Court is not inclined to grant anticipatory bail to the petitioner. The petitioner has to surrender before the respondent Police and seek regular bail. Hence, this anticipatory bail petition stands dismissed.
