The second respondent will conduct enquiry and forward the necessary proposal to the fourth respondent. The fourth respondent shall pass appropriate order on merits and in accordance with law within a period of eight weeks after receipt of proposal from the second respondent. The entire exercise will be completed within a period of five months from the date of receipt of a copy of this order. This writ petition stands disposed of accordingly. No costs.
