2.The learned counsel for the petitioner would submit that on the basis of the life threat made through whatsapp message, that was alleged to have been sent by the defacto complainant party, modification is requested.

3.The learned Government Advocate (Crl. Side) would submit that investigation has been completed and charge sheet is also made ready and it will be presented before the trial Court.

4.Considering the fact that the petitioner is the father-in-law of the deceased, condition imposed upon him is modified and the petitioner is directed to appear before the respondent police once in a week (i.e.,) on every Monday at 10.30 a.m. till the further condition period is completed. The other conditions in the said order remains unaltered.
