ORDER

This petition is filed seeking for a direction to transfer the investigation in Crime No.71 of 2023 dated 27.06.2023 from the file of the respondent No.3 police to the file of respondent No.2 police.

2.It is submitted by the learned counsel for the petitioner that on a complaint given by the petitioner that his wife is missing, the police have registered a case in Crime No.71 of 2023 under the caption 'woman missing' on 27.06.2023. It is further submitted that subsequent to that, there is no substantial investigation even after the petitioner has given some information about the culprit in this case.

3.The learned Government Advocate (Crl.side) on the other hand submits that the police have progressed substantially in this case and they could trace the victim girl at Thiruppur and the victim stated to have informed to her nephew,
