Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a writ of Certiorarified Mandamus calling for the records relating to the orders passed by the 3rd respondent in his proceedings in Na.Ka.No.4176 / A3 / 2013 dated 20/04/2018 and quash the same and consequently direction may be issued to respondents to approve the petitioners appointment as Secondary Grade Teacher in 5th respondent school from the date of the joining on 02/07/2012 with all service and monetary benefits by sanctioning grant within stipulated time.
