According to learned counsel for the petitioner, on a complaint given by the *defacto* complainant, a case has been registered in Crime No.275 of 2017 on the file of the respondent Police for the offences punishable under Sections 341, 294(b), 324, 355, 506 (2) and 420 of I.P.C. It is submitted that, subsequently, there is no progress in the investigation, and thereby, sought for suitable directions.

3. Learned Government Advocate (Criminal Side) on the other hand, submits that, the respondent Police have completed the investigation and they have served the copy of the final report to the *defacto* complainant on 20.07.2023 and further submitted that they are going to submit the final report before the concerned Court.

4. Learned counsel for the petitioner has also confirmed that the petitioner has received RCS notice.

5. Considering the same, once investigation has already been completed, no further directions can be given to the respondent Police for expediting the investigation.

6. Accordingly, the Criminal Original Petition is dismissed as infructuous. However, the petitioner is at liberty to challenge the referred charge sheet before the concerned Court.
