ORDER

The present writ petition has been filed to call for the records pertaining to the proceedings of the impugned notice in Memo No.CFL/RC-MDU-PR26/2023, dated 30.06.2023 on the file of the respondent and to quash the same.

2. Heard the learned counsel appearing on either side and perused the materials available on record.

Today, when the matter was taken up for hearing, the learned Standing Counsel appearing for the respondent would submit that similar matter was placed before the Principal Bench and the impugned order with respect to the similarly placed person was quashed in WP(MD).No.20528 of 2023, dated 14.07.2023. Hence, it was submitted that the respondent University may be permitted to withdraw the order, dated 30.06.2023 for the purpose of following the similarity between the case filed by the identical person viz., B.Lakshmipathi before the Principal Bench of this Court.
