PRAYER :-

To enlarge the Petitioners on bail in the event of their arrest in execution of NBW warrant in SC.No.119 of 2019 on the file of the Fast Track Mahila Judge,Dindigul in Cr.No.131 of 2016 on the file of the Respondents.

Today, when the matter is taken up for hearing, it is submitted by the

learned Government Advocate (Crl.Side) that the petitioner along with other accused are facing trial in S.C.No.119 of 2019, pending on the file of Fast Track Mahila Court, Dindigul and at the time of questioning all the accused persons remained absent, thereby, the learned Judge has issued Non-bailable warrant against them. Seeking anticipatory bail, this petition has been filed.

2.Since, Non-bailable warrant is issued against the petitioner, he cannot seek anticipatory bail at this stage. The petitioner has to surrender before the concerned Court and seek relief. The petitioner is not entitled for anticipatory bail, though the co-accused have already been granted anticipatory bail.

3.Accordingly, this Criminal Original Petition stands dismissed.
