PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For Anticipatory Bail in Crime No.315 of 2023 on the file of the Respondent Police.

ORDER : The Court made the following order :-

Today, when the matter is taken up for hearing, it is submitted by the learned Government Advocate (Crl.Side) that the petitioner has moved anticipatory bail petition before the learned Principal District Judge, Pudukkottai in Crl.M.P.No.1614 of 2023 and the same was considered on 17.05.2023 and condition was imposed upon the petitioner to deposit a sum of Rs.50,000/-. The petitioner could not comply the

condition and filed a petition seeking modification stating that the time mentioned in the petition is lapsed. Again seeking anticipatory bail this petition has been filed.

2.In view of the above, the petitioner cannot seek anticipatory bail at this stage. The petitioner has to represent the petition to modification before the concerned Court and the learned Judge may consider same on its own merits.

3.With the above directions, this Criminal Original Petition stands disposed of.
