PETITIONS FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For Anticipatory Bail in Crime No.2 of 2018 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner / Accused, apprehending arrest at the hands of the respondent police for the alleged offence punishable under Sections 120(B), 406 and 420 of IPC in Crime No.2 of 2018 on the file of the respondent police, seeks anticipatory bail.

2. When the matter was taken up for hearing, the learned counsel for the petitioner submitted that the petitioner has been arrested and remanded to custody on 20.07.2023 and he expressed his grievance that at the time of remand, the

petitioner was admitted in the Stanley Government Hospital, Chennai, for his health condition and had been taking treatment there. Now he is in judicial custody.

3. If the respondent police are making trouble to the petitioner, the learned counsel for the petitioner may make a mention before the learned Judicial Magistrate No.2, Virudhunagar. Since the petitioner has been arrested and remanded to judicial custody, the purpose for which the petitioner has been filed, has become infructuous.

4. Accordingly, this Criminal Original Petition stands dismissed as infructuous.
