ORDER

This petition is filed seeking for a direction to the respondent police not to harass the petitioners under the guise of enquiry and not to intervene in the civil dispute between the petitioners and the respondent No.3.

2.It is submitted by the learned counsel for the petitioners that there are civil disputes between the petitioner and the respondent No.3 in respect of the property belonging to a Mosque and that on a false complaint given by the respondent No.3, police are harassing.

3.The learned Government Advocate (Crl.side) has reported that the representation of the respondent No.3 has already been disposed of on 19.07.2023

and stated that subsequent to the disposal of the representation, the petitioner was never called and the allegation of harassment is incorrect.
