Eventhough the matter has been filed for cancellation of bail, that was granted to the respondent, now a compromise has been reached between the parties by which the amount of Rs.71,000/- has been paid in the form of Demand Draft drawn in favour of the petitioner herein. The petitioner has also received the demand draft.

2. Learned counsel for the respondent also undertook that he will continue to pay Rs.6,000/- (Rupees Six Thousand only), for a month to the petitioner, directly to the account of this petitioner, within 5th of every month, without fail.

3. This undertaking is placed on record. If any violation of the undertaking is noticed, the petitioner is at liberty to approach this Court for appropriate orders. Nothing survives for adjudication in this case.

4. Accordingly, this Criminal Miscellaneous Petition stands disposed of.
