2. The learned counsel for the petitioner seeks time to produce sureties, since the petitioner is unable to mobilise the fund and execute the sureties within the stipulated time prescribed by this Court.

3. The defacto complainant's counsel makes objection to the effect that already undertaking was given by the petitioner to settle the issue. Inspite of the same, the petitioner seeks extension of time.

4. The learned counsel for the petitioner would submit that only for the purpose of settling the above said issue, he seeks extension of time.

5. Recording the submission made by the learned counsel for the petitioner, time granted by this Court vide order in CrI.O.P(MD) No.10824 of 2023, dated 19.06.2023 is extended further for a period of fifteen days from the date of receipt of copy of this order.
