“DrugOffender” C.No.53/Detention/C.P.O./TC/2023, dated 11.06.2023 passed by the second respondent under u/s.3(1) & u/s.3(2) of the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Cyber Law Offenders, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Sexual Offenders, Slum Grabbers and Video Pirates Act (Tamilnadu Act 14 of 1982) and set aside the same and direct the respondents to produce the body of the detenu before the Hon'ble Court now confined in Central Prison, Tiruchirappalli and set him at liberty.
